When the post-test review process is administered locally, we provide a list of question references, the answer key, appeal forms and a final report discussing any challenges to the questions. After the test has been administered and scored, we provide an enhanced report of the exam results, including score listings, descriptive statistics, detailed comments on individual candidates and a passing point recommendation for those clients who do not have a fixed minimum cutoff score.
